

Groundwater Pollution Control Standards

Six articles promulgated by Environmental Protection Administration Order (90) Huan-Shu-Shui-Tzu No. 0073680 on November 21, 2001.

Revisions to Article 4 promulgated by EPA Order Huan-Shu-Shui-Tzu No. 0980003647 on January 15, 2009.

Article 1

These Standards are determined pursuant to Article 5, Paragraph 2 of the Soil and Groundwater Pollution Remediation Act.

Article 2

If the concentration of substances in the groundwater meets the pollutant control values listed in these Standards, but the substance is not due to contamination caused external pollution, then these standards does not apply.

Article 3

Groundwater is classified into the following two categories:

- I. Category 1: Drinking water from groundwater sources in protected areas
- II. Category 2: Groundwater which is not of Category 1

Article 4
